#### SITE PREPARATION

 Gordon Farquharson updated the group on the site preparation plans. The Water Resource Agency is nervous about us cutting into the concrete to install the lightning protection on the levee. Jeff said that their proposal to put a meter depth of gravel on top of the levee would not work because we would not be able to get the crane and other vehicles on top of the levee.

### SHIPPING

- Wen-Chau met with the Seajet representative (Joseph Wang). He showed him the location of the levee site.
- Shipping will cost around \$100,000. Four of the containers have been given a hazmat rating which has increased the shipping costs.
